Professor Franco Ferrari

NYU New York

Professor Franco Ferrari joined NYU School of Law as a full-time professor in the Fall of 2010, after serving as a professor of law at Verona University (2002-2016), Bologna University (1998-2002), and Tilburg University (1995-98).

Professor Ferrari, a former legal officer at the UN Office of Legal Affairs, works and does research in the areas of international commercial law, conflict of laws, comparative law, and international commercial arbitration. He also acts as an international arbitrator both in international commercial arbitrations and investment arbitrations.



Professor Peter Arnt Nielsen

Copenhagen Business School

Peter Arnt Nielsen is professor at CBS and external professor at the College of Europe, Bruges. He conducts research in and teaches Danish and international arbitration, mediation, and litigation, and Danish and international contract law.

Professor Nielsen is and has been member of several national and international legislative committees and working groups in the European Union and the Hague Conference for Private International Law. He is member of Groupe européen de droit international privé and the International Academy of Comparative Law. Peter Arnt Nielsen is also a Certified Arbitrator and Mediator as well as a Court Mediator.



Dr Friedrich Rosenfeld

Dr. Friedrich Rosenfeld is a Partner at HANEFELD, an arbitration boutique with offices in Hamburg and Paris. He has acted as counsel and arbitrator in cases involving a range of applicable substantive laws and seats (e.g. Austria, Denmark, England, Germany, Greece, Israel, Qatar, Switzerland, Turkey, and the United States).

Former corporate lawyer, since 2002 arbitrator under the arbitration rules of numerous institutions and *ad hoc*. Professor Cordero-Moss is, *inter alia*: member of the Curatorium of the Hague Academy of International Law (since 2019); member of the ICC Court of Arbitration (since 2018); member of the Council, Arbitration Chamber of Milan (since 2017); member of the Board, Arbitration Institute, Oslo Chamber of Commerce (since 2010); former president (2017-20) and judge (2007-2020) of the European Bank for Reconstruction and Development Administrative Tribunal; vice-president (since 2014) of the Board of Directors, Norwegian Financial Supervisory Authority; member (since 2015) of the Norwegian Tariff Board on general application of wage agreements.

Jonathan Lim is a triple-qualified English solicitor, Singapore advocate and New York lawyer with a focus on complex international disputes. He has particular experience with disputes in the energy, financial services, technology and telecommunications sectors, and has represented clients in commercial and investment treaty arbitrations in Asia, Africa, Europe and the Americas. He has also worked on WTO dispute settlement matters involving claims under multiple WTO agreements (including GATT, GATS, TRIPS, TBT and SCM) and is part of the team representing the government of Somalia in its WTO accession process.

Mr Lim has a developing practice as arbitrator and has received appointments as sole and party-appointed arbitrator in proceedings seated in Europe and Asia, including bilingual English-Chinese arbitrations and arbitrations governed by the CISG. He has also advised international organisations and governments in Africa and Asia on public international law issues and assisted with the drafting of legislation in Fiji, Iraq, Papua New Guinea, Somalia and Tonga. Mr Lim is also a Visiting Senior Fellow at the National University of Singapore, where he teaches a course on commercial and investment arbitration each year.
